Hon'ble Excellency Rashtrapati Ji,

In exercise of your power conferred under Article 156 (1) of the Constitution of India, we respectfully submit, you may be graciously pleased to kindly consider withdrawing your pleasure for holding the office of Governor of West Bengal by Hon'ble Shri Jagdeep Dhankhar for serious breach of oath of his office, which, in terms of Article 159 of the Constitution, stipulate as follows:

"...preserve, protect, defend the Constitution and the law, and devote himself to the service and well being of people of West Bengal".

We submit that Hon'ble Governor Dhankhar has failed to preserve, protect and defend the Constitution, and repeatedly breached law declared by the Hon'ble Supreme Court. From the seat of highest Constitutional office in the State, Hon'ble Governor Dhankhar has been inducing divisive politics, just because ruling parties at the Centre and State are political opponents. We had expectations, that after being nominated to the high Constitutional post in the State, Governor Dhankhar would rise above his political past, act impartially towards all political parties. Our expectations stand belied.

Some of the recent words/utterances/tweets/media briefing directed against the West Bengal Government, Hon'ble Chief Minister and All India Trinamool Congress reflect flagrant disregard to constitutional norms, proprieties and ethics. Some remarks are provocative and incite action which could lead to law and order problems. These cast a shadow over the impartiality and bonafides of the Hon'ble Governor. Here are some examples:

The above words, remarks, tweets and press statements made by the Governor are contrary to several judgments of the Hon'ble Supreme Court. You may kindly take note of them so that the law declared by the Hon'ble Supreme Court reigns supreme. Some relevant judgments are as follows:

SHAMSHER SINGH vs STATE OF PUNJAB - AIR 1974 SC 2192

[7 Judge Bench of Hon'ble Supreme Court]

In this judgment Hon'ble Supreme Court held, inter-alia, as follows:-



"For a Centrally appointed Constitutional functionary to keep a dossier on his Ministers or to report against them or to take up public stances critical of Government policy settled by the Cabinet or to interfere in the administration directly – these are constitutionally faux pas and run counter to parliamentary system."

RAMESHWAR PRASAD vs UNION OF INDIA- AIR 2006 SC 980

[5 Judge Bench of Hon'ble Supreme Court]

In this judgment Hon'ble Supreme Court relied upon a 9 Judge Bench judgment of the Hon'ble Supreme Court of S.R.Bommai case [AIR 1994 SC 1918] and the role of the Governor came in for considerable criticism on the ground that some Governors had failed to display the quality of impartiality expected of them. The Hon'ble Supreme Court held that the Governor's action should be to protect Constitution and not to promote the political interest of any political party.

S.R.BOMMAI vs UNION OF INDIA – AIR 1994 SC 1918

[9 Judge Bench of Hon'ble Supreme Court]

In this judgment, in the context of Article 356, Hon'ble Supreme Court put a bar on dismissal of the State Government by the Centre for political gain. [when different political parties are in power at the Centre and the State].

The Hon'ble Supreme court held that secularism is one of the basic features of the Constitution. In matters of State, religion has no place. No political party can simultaneously be a religious party.

NABAM REBIA vs DEPUTY SPEAKER - (2016) SCC ON Line 694

[5 Judge Bench of Honb'le Supreme Court].

In this case, in a different context, it was further held that "it is an accepted principle that in a parliamentary democracy with a responsible form of government, the powers of the Governor as Constitutional head of the State should not be enlarged at the cost of real executive, viz, the Council of Ministers".

The Hon'ble Supreme Court highlighted how Article 163 of the Constitution does not give the Governor "general discretionary power to act against or without the advice of his Council of Ministers."

"The area for existence of his discretion is limited. Even in this limited area, the Governor's choice of action should not be arbitrary or fanciful. It must be a choice dictated by reason, actuated by good faith and tempered caution."

You will kindly agree that these laws declared by the Hon'ble Supreme Court are binding on all courts within the territory of India. You will further kindly agree that all authorities, civil and judicial, in the territory of India, shall act in aid of the Supreme Court. These follow from articles 141 and 144 of the Constitution.

Hon'ble Shri Dhankhar has shown propensity to transgress upon jurisdiction of other constitutional authorities. His curious comments about free and fair election in West Bengal and seeking information about expenses of industrial meetings are within the jurisdiction of Election Commission and CAG (through AG Bengal to be placed before the State Assembly) respectively. Seeking apology from the Hon'ble Chief Minister of the State on an unfortunate incident on BJP President's convoy is another transgression by the Governor.

For serious breach of Constitutional norms, ethics and, in particular, for repeatedly violating articles 159, and 144 (oath of office, and law declared by the Hon'ble Supreme Court), we do sincerely hope and pray that you would be graciously pleased to consider withdrawing your pleasure under article 156 (1) of the Constitution so that people of West Bengal are not subjected to the vicissitudes of a political opponent, blatantly acting through the office of Governor.

Interminable critical tweets and statements directed against the West Bengal Government, the Hon'ble Chief Minister, AITC – with a political bias - are likely to cause law and order problem. Besides, such tendencies and inclinations on the part of the Constitutional head of the State to openly support a political party strikes at the very root of federalism which the Hon'ble Supreme Court has held to be a basic structure of India's Constitution.

We place it on record that West Bengal witnessed 663 political murders between 2001 and 2011 whereas it came down to 113 during Ms Mamata Banerjee led government from 2011 to 2019 (source NCRB). The Maoist infested Jungle Mahal areas of the South Bengal districts bordering Jharkhand and Odisha were also freed from extremists' politics of

annihilation through administrative initiatives and political process ensured by Ms Mamata Banerjee led AITC government since 2011. The unending violent situation in the hills of Darjeeling, Kalimpong, Kurseong, Mirik and parts of Dooars which was prevailing for decades was brought under control by the government of West Bengal and peace and tranquillity have since restored in those areas. Even foreign and local tourists have started arriving there in thousands on New Year's eve. The secessionist activities of another outfit, KLO have also been curbed in a peaceful manner throughout the North Bengal districts. All this notwithstanding, the Hon'ble Home Minister Shri Amit Shah spread canards against the government of West Bengal during his visits to the State in November and December this year. His comments on the issue of law and order situation were echoed and amplified by the Hon'ble Governor Shri Dhankhar through his tweets, Press Statements and Press Conferences. Such a public stance adopted by Hon'ble Shri Dhankar against the State Government (describing the law and order situation to be at its lowest ebb and demanding apologies from the elected Chief Executive in public) is not only unprecedented, unwarranted, and uncalled for, but also smacks of his hypocrisy to act under the orders of his masters in Delhi. He shows no will to protect or defend the Constitution. In fact, Hon'ble Dhankhar is acting at the behest of ruling party ministers and leaders to denigrate the image of the Government of West Bengal in the eyes of the people.

Hon'ble Shri Dhankhar's brazen public defence of an accused person, presently under investigation by the police in a serious criminal case, and also for persons like a chartered accountant allegedly involved in manipulating accounts of a 'scam' (now in police custody) are other examples of his blatant violation of 'oath of office'.

There is more. Hon'ble Shri Dhankhar had termed a death by suicide (as per post mortem report) as a 'political murder'. We are referring to the unfortunate death of the MLA of Hematabad A.C. in Uttar Dinajpur district. He did this to appease the ruling party leaders at the Centre. Police investigation has now revealed that the said MLA was involved in embezzlement of funds of a bank of which he was a Director. As the investigation was progressing on that economic offence, the MLA opted for death by suicide.

Hon'ble Shri Dhankhar is holding Press Conferences, briefing the media from Raj Bhawan, joining TV channels regularly as commentator and panellist. As if all this was not enough, he has gone to the extent of naming and defaming Senior Officers of the Civil and Police Services of West Bengal, thereby denigrating their official positions in the eyes of the people. It is common knowledge, that these government officials do not have any recourse to respond to such insinuations/allegations which are otherwise politically motivated, baseless,

vexatious, false in furtherance of his 'collusive conspiracy'. He has engineered to destabilize the State Government machinery as a whole.

Hon'ble Shri Dhankhar has also not spared the State Legislature. He is sitting tight and refuses to sign a number of Bills passed by the West Bengal Legislative Assembly. Notonly is he not signing the bills, he is even asking for "explanations" from the Hon'ble Speaker. This is a direct insult and attack on the Sovereignty of the State Legislature.

In the above facts and circumstances, we submit to Your Excellency to kindly consider initiating action against Shri Jagdeep Dhankhar, Hon'ble Governor of West Bengal for his acts of omission and commission as narrated hereinbefore in details taking into account all legal, constitutional aspects together, before it is too late for the people of West Bengal to further suffer prejudicially at the hands of advocates of majoritarianism and/or unitarianism against the spirit of very first Article of Indian Constitution, i.e., "India, that is Bharat shall be a Union of States".

Kindly do take action. It has already gone too far.
